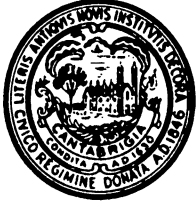

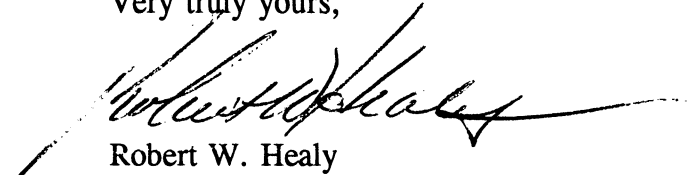

To The Honorable, The City Council:

I am hereby requesting the appropriation of \$68,277.00 in the Grant Fund of the Department of Human Services Salary and Wages Account (\$67,437.00), Other Ordinary Maintenance Account (\$641.00) and Travel and Training Account (\$200.00) from the Massachusetts Department of Public Health's Tobacco Control Program. These funds will be used for the Department's Tobacco Education Program which will provide tobacco education services to populations at-risk such as women, people of color and linguistic minorities. The funds will be used to pay salaries, wages and benefits for staff, general operating expenses of the grant and required training expenses. The funding is derived from the Commonwealth's tax on cigarettes.
