NOTICE OF RECEIPT OF OUTDOOR ADVERTISING PERMIT RENEWAL APPLICATIONS FOR OUTDOOR ADVERTISING SIGNS IN YOUR MUNICIPALITY

Dear Sir/Madam:

We are notifying you of application(s) for renewal of outdoor advertising signs located in your municipality in compliance with MGL Chapter 93, Section 29A. Please review the application(s) carefully.

Please notify us in writing WITHIN 30 DAYS OF RECEIPT OF THIS LETTER whether your municipality objects to the renewal of permit(s) for these application(s) as required under MGL, Chapter 93, Section 29A. If your municipality objects, please state specifically the ground(s) for the objection to enable the applicant to respond thereto and the Board to issue its determination. For your information, a copy of the Board's requirements for permits is enclosed.

If you register an objection within 30 days, the Outdoor Advertising Board shall notify the applicant of the objection; the applicant will then have 10 days from receipt of that notice to respond thereto. The Board will thereupon make a preliminary determination. If the Board grants the renewal, you may request a hearing within 15 days of that notice; if the Board denies the renewal, the applicant then has 15 days to request a hearing.

Please note that if your municipality does not object to the application(s) in the required time, the Board shall make a preliminary determination to grant or deny the renewal(s) and notify both you and the applicant. You or the applicant may then request a hearing before the Board which will hold a hearing before making a final determination. If you or the applicant do not request a hearing, the preliminary determination becomes final.

We rely upon your continued cooperation and greatly appreciate your interest in these matters.

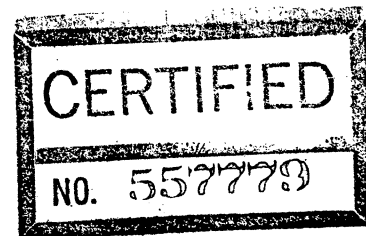
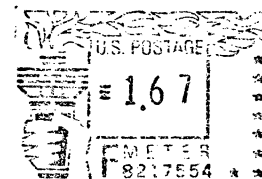
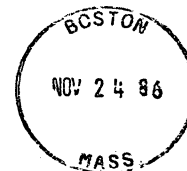
