To The Honorable, The City Council:

Attached is an order requesting the appropriation of \$39,660.00 in the grant fund from the Federal McKinney Act through the Mass Department of Education to the Human Services's Salary & Wages Account \$32,286.00, Other Ordinary Maintenance Account \$6,074.00 and Travel and Training Account \$1,300.00 to provide funds for adult education services for homeless people. Funds will conduct outreach to 200 homeless adults in Cambridge and will provide instruction and educational counseling to 30 heads of household residing at family shelters and individual homeless adults.
