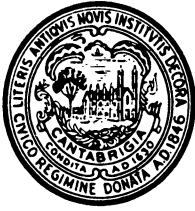

To the Honorable, the City Council:

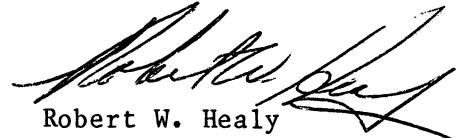
The Cambridge City Hospital is interested in leasing part of the building located at 650 Cambridge Street for a Neighborhood Health Clinic. This would enable the City Hospital to combine two health clinics in the area into one. Furthermore, this has met with community approval.

One-third of the property at 650 Cambridge Street is owned by Michael Costello, an attorney who primarily handles the hearings at the Industrial Accident Board for the City. His position with the City is unique, in that he is registered as the Workers' Compensation agent for the City of Cambridge. Also, Mr. Costello does not participate in or have any official responsibilities for the Cambridge City Hospital.

In order to be certain that there is no conflict of interest with the City, it is respectfully requested that Mr. Costello be made a special employee in accordance with Chapter 268A of the Massachusetts General Laws.

Therefore, it is requested the City Council approve the recommendation that Mr. Costello be made a special municipal employee for the City of Cambridge.
