ORDERED:

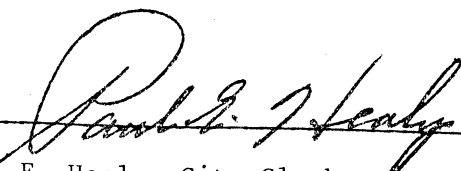

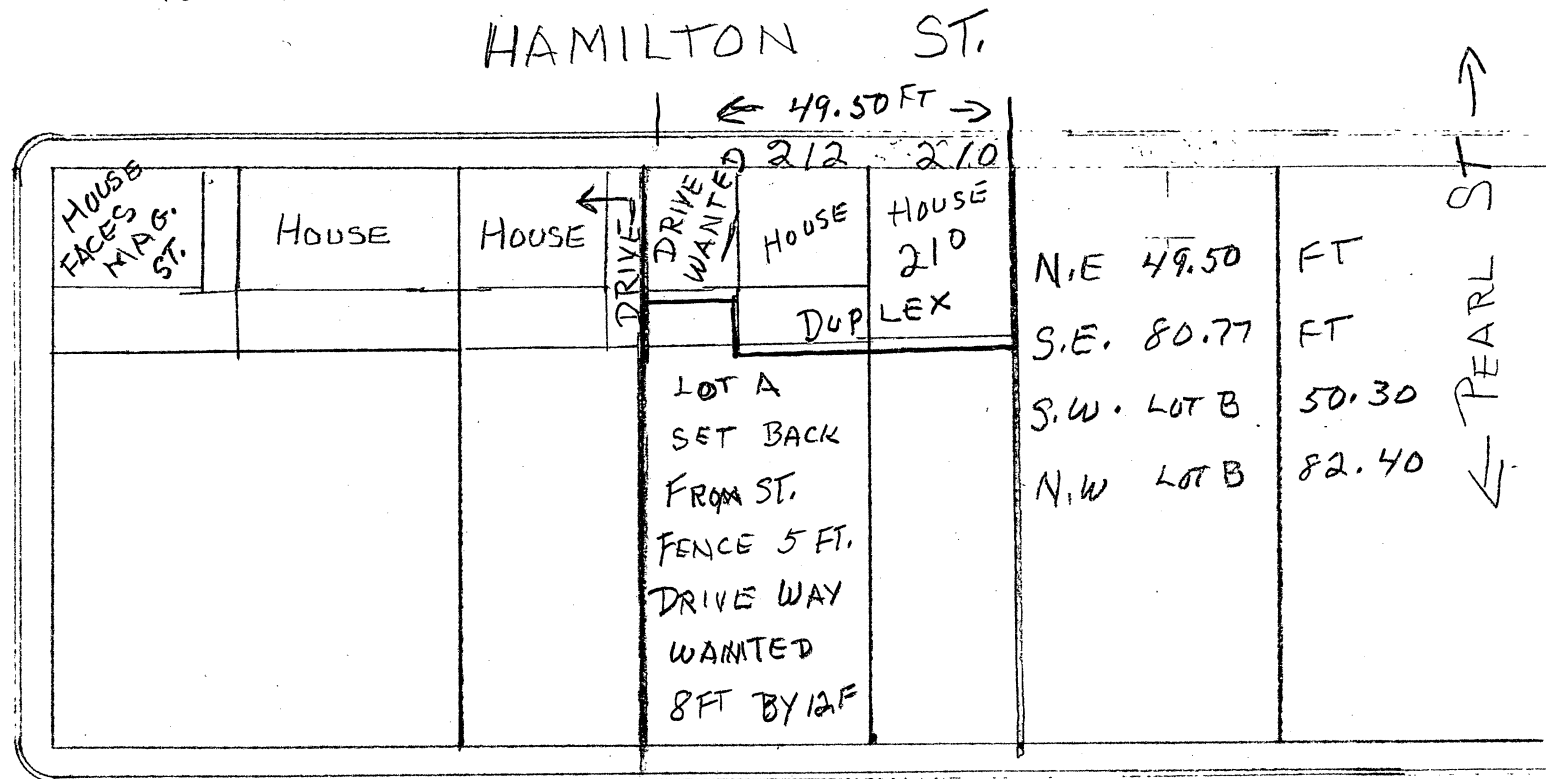
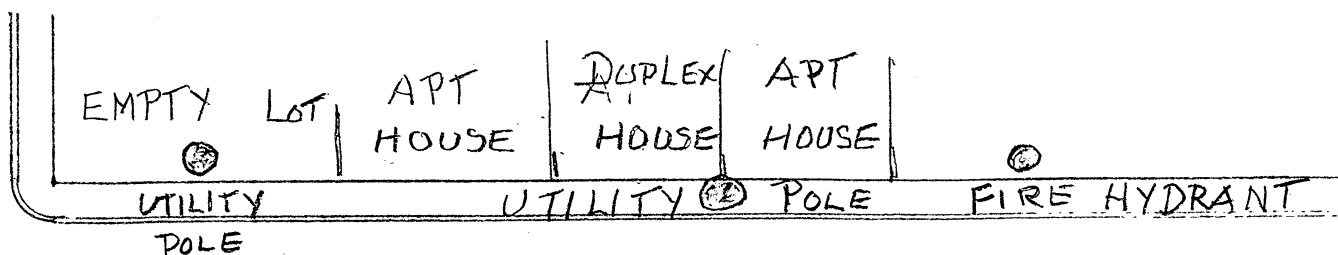
