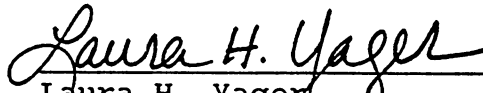
MOTION OF CITY MANAGER, ROBERT W. HEALY, TO INTERVENE

In support thereof, the City Manager of Cambridge submits MEMORANDUM IN SUPPORT and exhibits, annexed hereto.

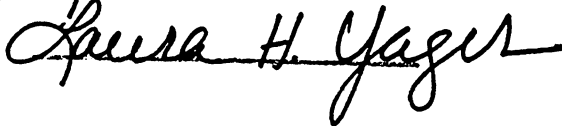
