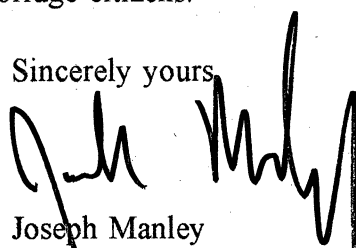
In all, 213 Cambridge residents have signed the petition in only a week. More signatures will be forthcoming.

This very strong response reflects a growing consensus in the Cambridge community:

- 1) Against the Hospital's takeover of Camelia Avenue houses and public way as a grave and damaging encroachment that threatens the entire future of the residential neighborhood;
- 2) That any hospital project be built well below maximum zoning levels;
- 3) That the financial risks of the project are too great in the absence of final national health care reform legislation, and definitive, hard, complete and objective facts on the impact of such legislation on the Cambridge Hospital.

We hope and trust you will honor these requests by Cambridge citizens.
