To The Honorable, The City Council:

I am hereby requesting the appropriation of \$33,900.00 in the Public Investment Fund of the Fire Department Extraordinary Account from Property Taxes. This appropriation will be used to provide additional funding for the purchase of the second rescue vehicle and for the repair of a 1250 GPM pump. The additional funding of \$3,900.00 is required for the purchase of the second rescue due to the costs associated with a new chassis year and the modifications necessary to accommodate specialized equipment. The additional funding of \$25,000.00 is required in order to repair of the 1250 GPM pump so that the unit can be certified to present standards.
