ORDERED:

That a license is hereby granted to Paul Naughton under the provisions of Chapter 159A for the operation of tour buses from Waltham over the following public ways in the City of Cambridge:

From Memorial Drive along the Charles River, (subject to the approval of the Metropolitan District Commission), taking a right turn on to Boylston Street through Harvard Square traveling along the area of the Cambridge Common and taking a left on to Brattle Street, at which point the tour bus will stop at the Henry Wadsworth Longfellow House. After a brief stop, tour bus will then travel down Brattle Street out to Route 2. Time of tour will take approximately one hour and ten minutes.

This license is granted subject to the condition that NO passengers will be picked up within the City of Cambridge, and any violation of this condition will result in the revocation of this license.

This license is further granted subject to the approval of the City Manager.
