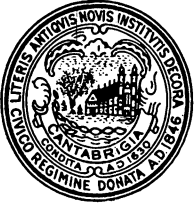


Dear Sir:

I hereby request an appropriation in the amount of \$175.00 to reimburse Paul DePrimio, an employee of the Public Works Department for damages in this amount.

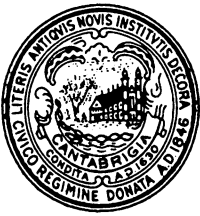
The Law Department, under the provisions of General Laws, Chapter 41, Section 100-A, defended an action against Paul DePrimio in which there was a judgment of \$175.00.


