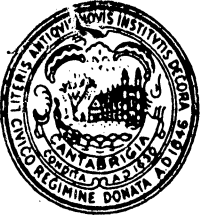

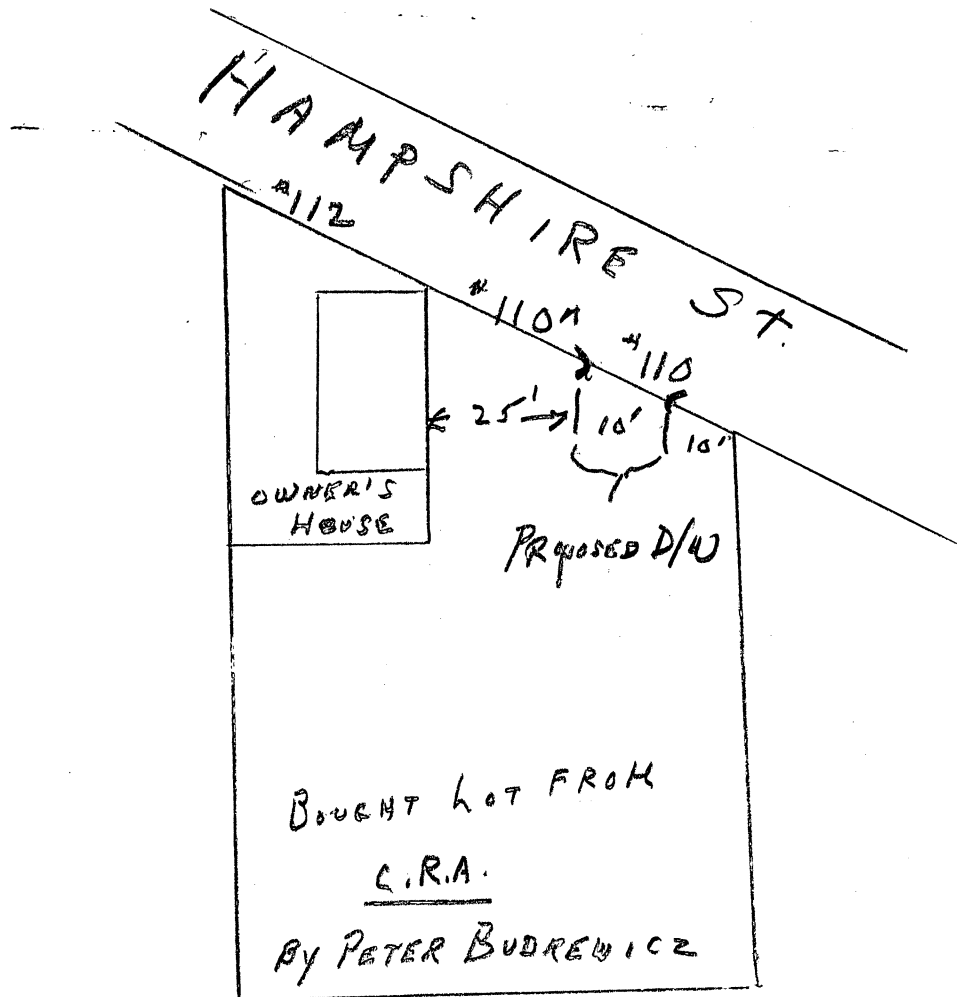

110-110A HAMPSHIRE ST.

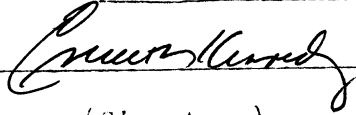
