- WHEREAS:** This City Council was deeply saddened upon learning of the death of Dr. Mary Ellen Mangano, a Cambridge native and late daughter of long time Cambridge Physician Salvatore Mangano; and
- WHEREAS:** Mary Ellen attended local elementary schools and graduated from Belmont High School in 1976, a cum laude graduate of Harvard University and had successfully completed medical studies at Tufts University School of Medicine; and
- WHEREAS:** Mary Ellen was a Boston Marathon finisher in 1981, 1982 and 1983 and was a member of the Harvard Women's Swimming Team from 1976 to 1979; and
- WHEREAS:** Dr. Mangano, Secretary of the Class of 1980, was the first woman member of the Association of Harvard Class Secretaries, a life-time position, and the first woman on the Harvard Varsity Club's Board of Directors; now therefore be it
- RESOLVED:** That this City Council go on record extending its deepest sympathy to Dr. and Mrs. Salvatore Mangano and to the entire family at this time of such personal loss; and be it further
- RESOLVED:** That the City Clerk be and hereby is requested to forward a suitably engrossed copy of this resolution to the Mangano family on behalf of the entire City Council.
