ORDERED:

That in accordance with Massachusetts General Laws, Chapter 44, Section 53A, the City Council approves the acceptance of a gift of Five Hundred (500) dollars to establish the Jeanne Kantor Landon Trust Fund to be used by the Cambridge Public Library for the following purposes:

To purchase books about art and artists anywhere in the world and from any historical period, thereby expanding and rounding out the library's present holdings in this area.

To purchase books about serious and light opera, thereby enlarging the library's opera collection and, in particular, strengthening the library's collection of opera scores and tape recordings.

It is assumed that each book or score purchased with monies from the Jeanne Kantor Landon Trust Fund will carry a book-plate indicating that the book is a gift in honor of Jeanne Kantor Landon from her family and friends.

It has been specifically requested by the donor that the principal be used by the library for its book purchases as necessary. The library is not restricted to the use of interest derived from the principal.
