Under no circumstances is this bond considered to be a substitute for the prior bond and in no event shall this bond provide coverage for any events occurring before its effective date.

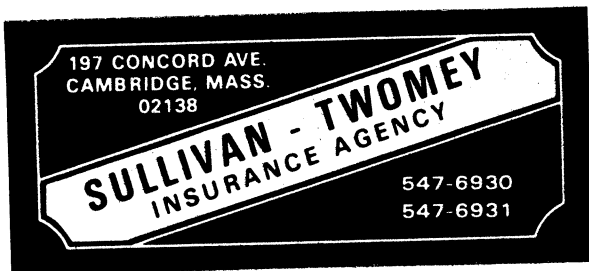
Nothing herein contained shall be held to vary, alter, waive or extend any of the terms, limits or conditions of the Bond, except as hereinabove set forth.

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

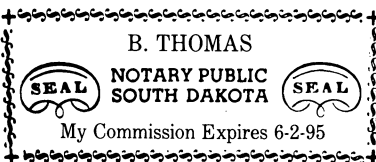
