To The Honorable, The City Council:

I am hereby requesting the transfer of \$5,000 from the General Fund Reserve Other Ordinary Maintenance Account to the Human Services Other Ordinary Maintenance Account. The Cambridge Food Pantry Network has asked that the City match funds they are providing to purchase 1,000 turkeys for the Thanksgiving Holiday. This request comes due to the loss of their corporate sponsor, Filenes Basement. In addition to the food panties, turkeys will also be distributed at Cambridge Cares About AIDS and the Riverside Neighborhood Health Clinic.

This transfer will support this year's effort while Project Bread works to secure a new corporate sponsor. As the City Council is aware, the City does provide \$81,000 annually to the Food Pantry Network.
