WHEREAS: The attached petition from residents of Eustis and Traymore Streets, Cambridge, in opposition to the application by Brodie Auto Rentals of 24 Eliot Street and 8-10 Eustis Street to acquire a license to sell used cars at 8-10 Eustis Street (Oxford Car Garage) raises serious questions about the uniform enforcement of the totality of the Cambridge Municipal Code by various city departments, particularly Inspectional Services Department and the Department of Traffic and Parking, so far as activities being carried on presently at the site in question and adjacent areas are concerned; now therefore be it

ORDERED: That the City Manager direct the Commissioner of Inspectional Services and the Director of Traffic and Parking to come before this Council at the earliest possible date to respond to the questions raised in the residents' petition as well as other questions relevant thereto posed by Council members and that the City Manager invite Mr. John Hall of Brodie Auto Rentals to be present and prepared to discuss and clarify the matters in question; and be it further

ORDERED: That the City Manager report back to this Council on March 27, 1989 with a date certain for this discussion.
