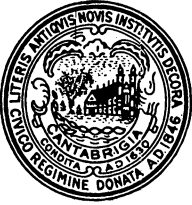


Dear Sir:

I hereby request an appropriation in the amount of \$525.00 to reimburse Frederick Theriault, an employee of the Electrical Department for damages in this amount.

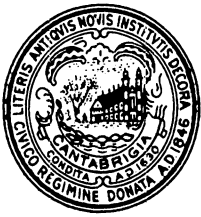
The Law Department, under the provisions of General Laws, Chapter 41, Section 100-A, defended an action against Frederick Theriault in which there was a judgment of \$525.00.


