Notice is hereby given that a public hearing will be conducted by the Massachusetts Industrial Finance Agency ("MIFA") on Wednesday, February 29, 1984 at ten o'clock in the morning at the offices of MIFA, 125 Pearl Street, Boston, Massachusetts on the proposal of Grobman Realty Company that MIFA approve a project to be located on an approximately 26,800 square foot parcel of land at 11 Brighton Street in the Town of Belmont, Massachusetts, a portion of which land is located in the City of Cambridge, Massachusetts, which parcel and building thereon is presently owned by Joseph P. Spinelli, and consisting generally of acquisition and improvement of the existing plant, including construction of a new roof; installation of new heating and cooling systems, sprinkler system, telephone system; and certain interior renovations, including construction of a new ceiling, and the estimated cost of such project in an amount not less than \$662,000 and authorize the financing of such costs by the issuance by MIFA, acting under and pursuant to Massachusetts General Laws, Chapters 23A and 40D, of industrial development revenue bonds in an aggregate principal amount not to exceed \$662,000, which bonds will not constitute a debt or pledge of the faith and credit of the Commonwealth of Massachusetts.
