ORDERED:

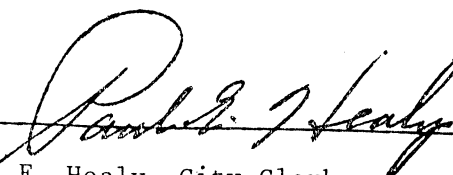

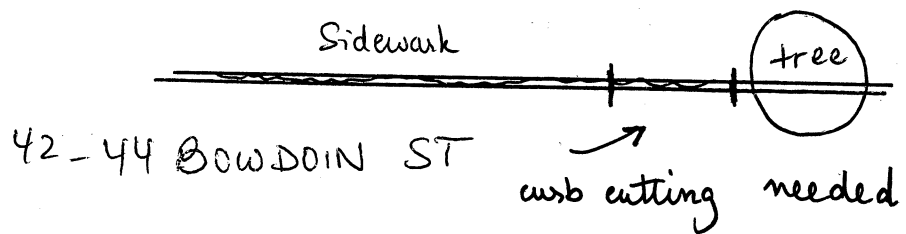
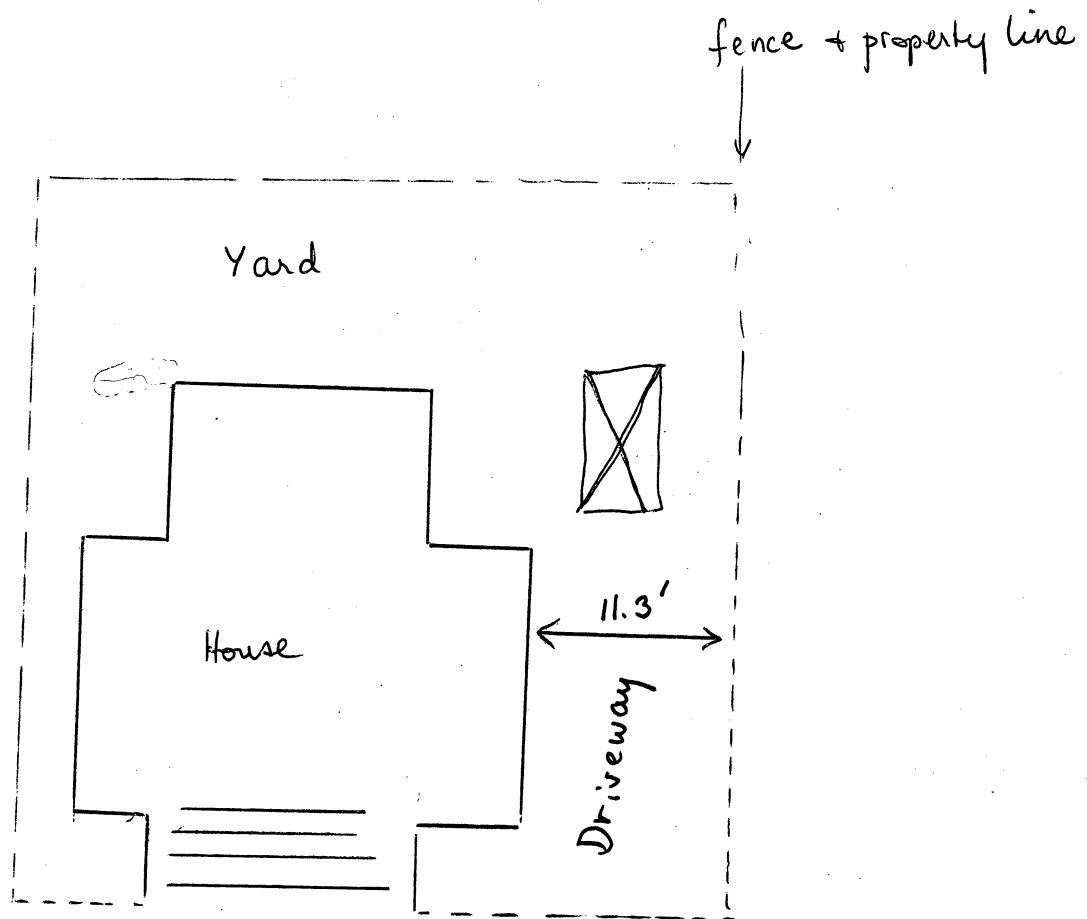
