Dear City Council,

to get right to the point I ask that you compose an order requesting the Cambridge Chronicle to print the Letter to the Editor here included.

In one of your recent meetings much was said about the benefits and affects of internationalism and regionalism. We are significantly affected by influences beyond our borders.

What I'm proposing is a way to manage those influences. People need wisdom in these kinds of affairs because one negative aspect of the inter-nationalistic point of view is it has no permanent bonds. They go where the pickins best. But happens to the people they leave behind ?

Cities need an innovative philosophy to insure their stability. So I ask you to read the letter as government officials and determine if its ideas are something you feel would be beneficial to Cambridge. And if you feel they are I ask you to ask the Chronicle to print it.

We need a paper that helps us deal with the things from outside that influence our lives. I approached the Chronicle 7 times with another concept for a way to achieve more stability for cities in trade matters. Once again the Chronicle refused to print it. These matters are not personal. The issue I'm asking your help in vitally relates to our city and every city's well being. We need ideas to stimulate us to think about these matters with deep, full understanding. The ideas covered in this letter take the focus and power away from distant officials and places the power where it should be in the cities where the people live their immediate meaningful lives.

Greater worldwide stability through worldwide wide city government coordination and priorities.

Humanity must once and for all time bring an end to internationalist and nationalist dominance in banking, financial activities, industry, commerce, medical, military and government activities.

Because on those levels history has clearly shown there is no sensitivity to what happens to the lives of the people who produce the wealth. The people who live in the cities. Other than those cities where the internationalists and nationalists have their headquarters and even there the lives of the poor remain unchanged. There are cases where dictators whether they be just that, or monarchists give the people money to keep them quite. But in the free capitalist countries and more so in the poor countries this is not so. The internationalists and nationalists control everything tightly.

The causes of human suffering would be greatly reduced if the wealth that humanity produces were shared more equitably. The majority of humanity are willing to be satisfied with living decently.

In order to achieve this there are places that are most vital to human life that must take prominence regarding international and national directives.

Those places that are most vital to human existence are the cities.

The cities must establish departments which gather international and national information regarding what is happening to other cities within a country and the world.

You may say the world media already does this. But comparing the accuracy of the stable alternative publications to the world media one can easily see that the world's major media is owned and controlled by the international and national factors and report to the public only according to how views will be beneficial to the intra-nationalist controllers. Here we create one word to represent both the internationalist and nationalist, intra-nationalist.

With this information the cities, which are the governmental structures most vital to the majority of humanity, will be able to support and coordinate with one another regarding unfair and harmful intra-nationalist activities.

Cities join together and form individual countries. Countries must develop and coordinate their individual defense organizations. It should be the cities of a country that formulate how the country's defense organization should be formalized. This formulation work has a specific purpose and should not require a permanent government body.

A country's defense organization must not be allowed to trespass on the rights and properties of the citizenry. The standard should be that a good national defense must have the foresight to perceive an enemy's moves and should have the know-how to relate such preparatory information to the citizens so that the lives of the citizens are not thrown into disarray.

Citizens must not live their lives so preoccupied with their personal affairs that they lose sight of the alertness needed to be aware of threatening national and international dangers. By this readiness they can better be aware of and support their country's military policies and actions.
