

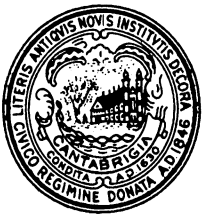
As you recall, on January 20, 1975 I initiated a study of the feasibility of sewer service charges, using a part-time person. The study report is due at the end of June.

The cost of this work is estimated at \$1,486.00, to be charged to A-2 allotment. To provide full coverage for this job, a transfer of \$1,000.00 from F-4 "Custodian of Foreclosed Property" to A-2 "Temporary Employees" is needed at this time.


