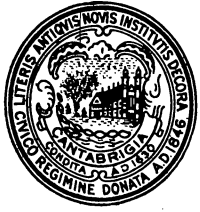
ORDERED:

Dear Mr. Corcoran:




