To The Honorable, The City Council:

I am in receipt of a gift to the City of Cambridge from Prince Turki of Saudi Arabia, following his stay in Cambridge.

This gift was encourage by the Vice Mayor Reeves as is noted in the Prince's letter. Accordingly, I am recommending the Acceptance and Appropriation of this gift of \$20,000 to the Department of Human Services. Additionally, I am recommending matching the gift with an appropriation of \$20,000 to Human Services Department from Unreserved Fund Balance.

This appropriation will be utilized for the purpose of enabling Cambridge Community Services to subsidize day care slots lost due to DSS subsidies and to make physical improvements to the facility as a revenue generator to enable the Center to continue to operate in the future without this support.

As with similar prior recommendations, this is a one time, non-recurring appropriation and will not be included in the FY92 operating budget.

Passage is recommended.
