that he be granted permission to have sewer and water entered from Upland Road into the newly-constructed private way, Newell Terrace.

The total distance from the middle of Upland Road would be approximately $156\frac{1}{2}$ feet (that is $24\frac{1}{2}$ feet from centre of Upland Road to edge of terrace, and 132 feet in the terrace)

It is the intention that two houses be put upon the lots to be used by this sewer and water

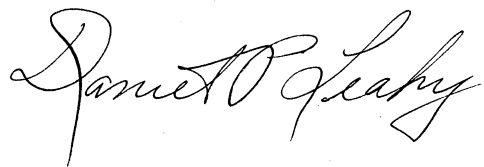
