Joint petition of the Boston and Maine Transportation Company and Eastern Massachusetts Street Railway Company for approval by the Department of Public Utilities of the transfer and assignment from the said Boston and Maine Transportation Company to the Eastern Massachusetts Street Railway Company of certificates of public convenience and necessity authorizing the operation of motor vehicles for carriage of passengers for hire as follows:

1. A portion of certificate No. 1994, D.P.U. 3632-B, dated June 30, 1950, as amended, over routes between the town of Billerica and the city of Boston, passing through the towns of Burlington, Winchester and Arlington and the cities of Woburn and Cambridge.
2. Certificate No. 3170, D.P.U. 12259, dated September 6, 1957, over routes in the City of Boston.
3. A portion of Certificate No. 687, D.P.U. 4034 over routes in the town of Westford and certificate No. 867, D.P.U. 4815, as amended, by D.P.U. 10272, over routes in the town of Chelmsford.

Upon the foregoing petition the Department of Public Utilities will hold a public hearing at its hearing room, 166 State House, Boston, on Monday, October 14, 1957, at 12:00 o'clock noon.
