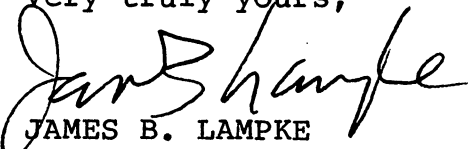
Dear Gentilepersons:
