ORDERED: That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to Katie Logue for the erection of a banner across Massachusetts Avenue at City Hall to the YMCA, Cambridge, Massachusetts.

Provided that, before erecting the above named banners, the petitioner shall obtain a permit from the Inspectional Services Department and file with the City Clerk a satisfactory bond in the sum of Two Thousand (\$2,000.) Dollars, conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said banners.

Dear Ms. Drury:

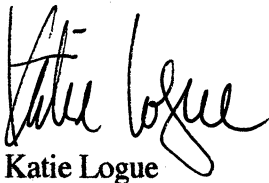
I have recently made arrangements with the Cambridge Mayor's Office to place a sign in front of City Hall to welcome the Dalai Lama of Tibet to Cambridge and to announce Tibetan Cultural Week: September 2 to September 10, 1995. (He will be speaking at the John F. Kennedy School of Government and at the Wang Center.)

I am writing to your office to request permission to hang a banner over Massachusetts Avenue in front of Cambridge City Hall and, if possible, a banner over Quincy Street in front of the Swedenborg Church, both during this same period. I was told by the City Manager's office that such requests must go before the City Council which is scheduled to meet on July 31st.

The banner will say: Cambridge Welcomes The Dalai Lama of Tibet - Tibetan Cultural Week: September 2nd to 10th. I understand that my organization, The Tibetan Association of Greater Boston, must provide the banner and that the Cambridge Forestry Department will actually hang it.
