ORDERED:

That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to Toscanini's Ice Cream for the ~~erection of a sign~~ placement of a nylon flag at 899 Main Street.

Provided that, before erecting the above named ~~sign~~ flag, the petitioner shall obtain a permit from the Building Department and file with the City Clerk a satisfactory bond in the sum of Two-Thousand Dollars (\$2,000) conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said ~~sign~~ flag.

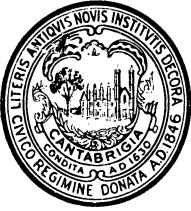
