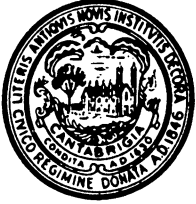

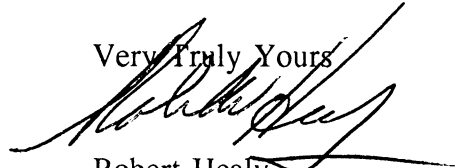

To The Honorable, The City Council:

I am hereby requesting the appropriation of \$80,326.00 into the Grant Fund of the Department of Human Services Salary & Wages Account (\$62,011.00), Other Ordinary Maintenance Account (\$18,165.00), and Travel & Training Account (\$150.00) from the Massachusetts Department of Public Health, Tobacco Control Program. DHSP operates the Tobacco Education Program for At Risk populations grant funded by the Department of Public Health through the Commonwealth's tax on cigarettes. The money is to be used to provide targeted outreach and education regarding tobacco to population deemed to be particularly at risk of tobacco use. This group includes low income persons, linguistic minorities, people of color, and women. Cessation support groups will be offered in various languages.
