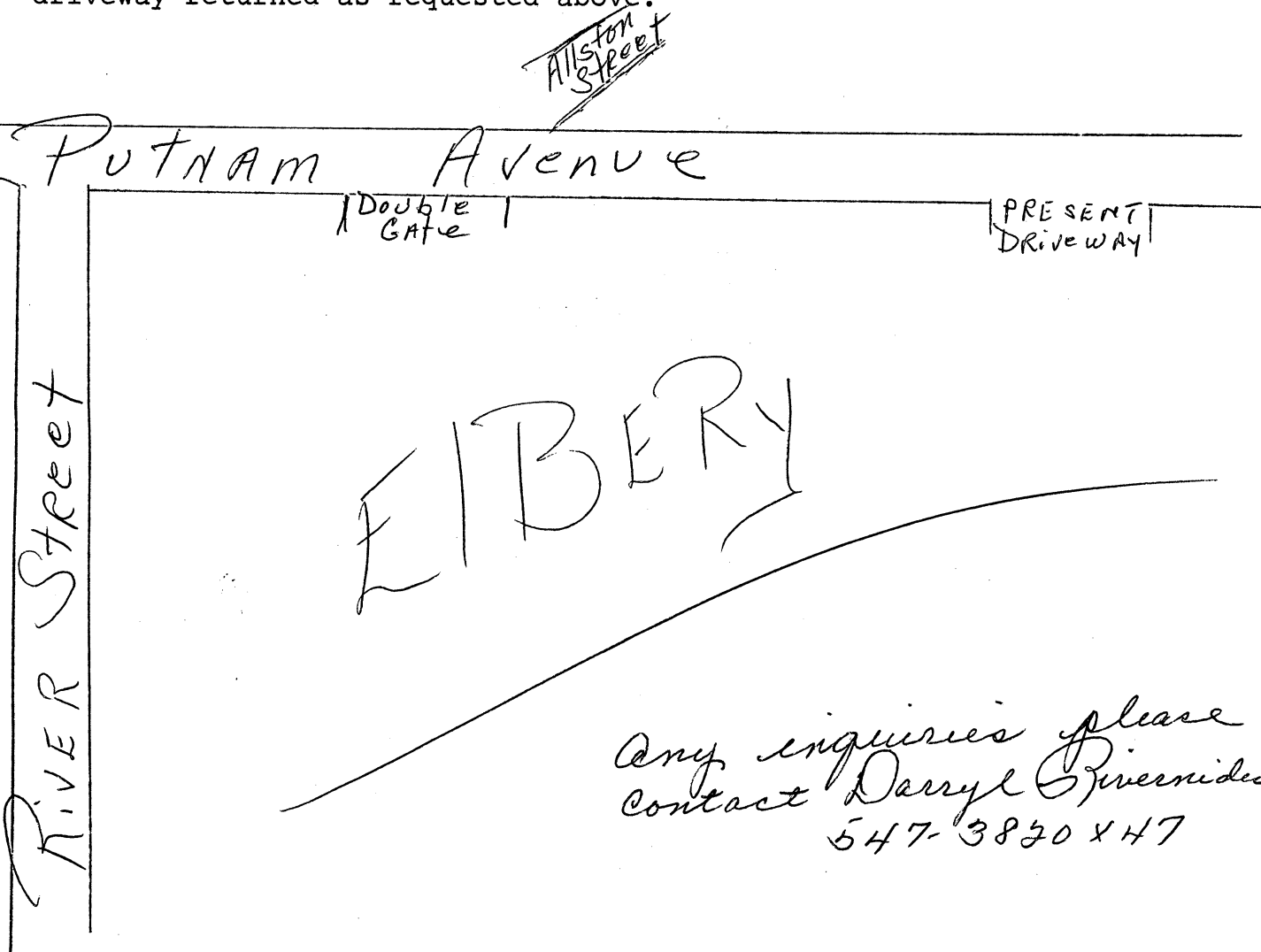

We are requesting that the driveway located at our double gates on Putnam Avenue approximately 150 yards from the corner of River Street be returned. There had been a driveway at that location up until approximately 5-6 years ago when the city poured new sidewalks the driveway was replaced with a full curb. We have closed our driveway on River Street due to the back up of traffic coming off the Mass Pike. We presently have a driveway on Putnam Avenue approximately 300-400 yards from the corner of River Street. We strongly feel the need to have the city return the original driveway and maintain the present driveway on Putnam Avenue to help alleviate the traffic situation. Both the MDC and Cambridge Police have requested that we do not receive our vehicle deliveries on River Street. In order to comply with their request, which we are more than happy to do, we desperately need the additional driveway returned as requested above.
