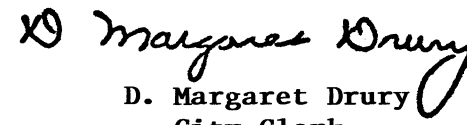

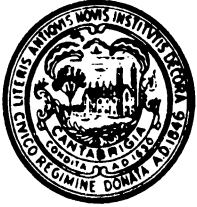

To The Honorable, The City Council:

I am hereby requesting the transfer of \$9,900.00 from Cable TV Salary & Wages Account to Extraordinary Expenditures Account. The transfer will allow for the purchase of three pieces of equipment to replace the dubbing station editor. The current editor replaced the defective system at the main editing station. The dubbing system allows the Cable TV Office the ability to duplicate different events and formats at the same time. At present the Cable TV Office runs from four to eight programs behind schedule for editing and each program can consume for two to five hours to edit. A second online video editor will allow Cable TV to stay up to date and will also allow cable the ability to fine tune programs for a desired look. The funds are available from salary outages in the Department.
