

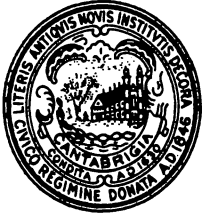

To the Honorable, the City Council:

Attached please find for your review and action an order requesting the acceptance and appropriation of a grant in the amount of \$53,279 from the Department of Public Welfare to the Department of Human Services Grant Fund Salary and Wages account (\$39,881), and Other Ordinary Maintenance Account (\$13,398).

The Community Learning Center has entered into a contract with the Department of Public Welfare to provide basic skills instruction for learning disabled people up to the fourth grade level. The Community Learning Center will provide instruction, workshops, and counselling support to assist students in dealing with life management issues associated with learning disabilities. The program will include recruitment, intake, diagnostic testing, placement in classes, classroom instruction, counselling and post program placement.
