Quincy Street between Broadway and Massachusetts Avenue.

Massachusetts Avenue between Quincy Street and Peabody Street.

Peabody Street between Massachusetts Avenue and Cambridge Street.

Cambridge Street between Peabody Street and Broadway.

Provided further that this license is granted subject to the approval of the City Manager.
