

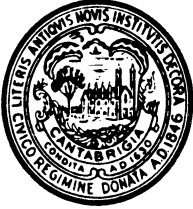

To the Honorable, the City Council:

This past June, the City Council adopted an interim zoning for the areas in the Cambridgeport Industrial District that were not addressed in the University Park rezoning. This action is part of a broader planning effort to study the numerous zoning, transportation and urban design issues surrounding future development in this area. The planning effort will continue over the next several months and is intended to lead to the drafting of a rezoning petition to be filed next May.
