To The Honorable, The City Council:

I am hereby requesting the appropriation of a grant from the U.S. Department of Justice, Office of Community Oriented Policing Services for \$39,614 to the Police Salary and Wages Account (\$5,000), Other Ordinary Maintenance Account (\$27,250), and Travel and Training Account (\$7,364) to provide funds for a partnership with the Harvard University Police Department, M.I.T.
