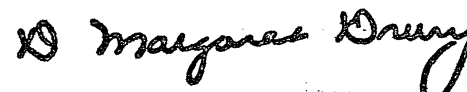

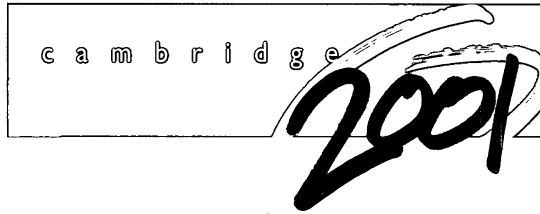

I am hereby requesting an appropriation of \$60,000 in the Grant Fund of the Human Services Salary and Wages Account \$37,823, and Other Ordinary Maintenance Account \$22,177. The Massachusetts Department of Education through the Massachusetts Children's Trust Fund (MCTF) is continuing to support the Center for Families of North Cambridge for the delivery of a Massachusetts Family Center program.
