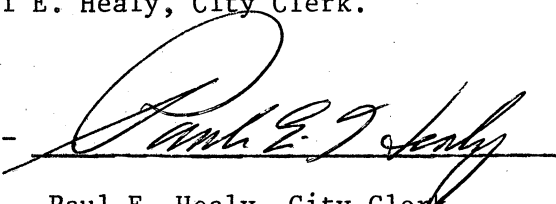

- WHEREAS: The 1985 Middlesex County tax was \$16,009,722.; and
- WHEREAS: The City of Cambridge paid some \$931,918. to Middlesex County in the form of County taxes; and
- WHEREAS: Middlesex County uses 71.79% of its collected taxes to operate its correctional facilities, and Cambridge provides some \$669,080. toward said operation; and
- WHEREAS: State assumption of County corrections could mean a savings of its entire local share of some \$669,080. for the taxpayers of Cambridge; now therefore be it
- RESOLVED: That the Cambridge City Council go on record urging the State Legislature to pass into law legislation presently before the House Committee on Ways and Means for State assumption of County corrections.
