

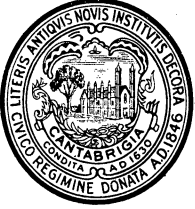

It is hereby requested that in addition to the amounts already provided the following sum be appropriated:


To The Group Insurance Account. . . \$57,126.89
