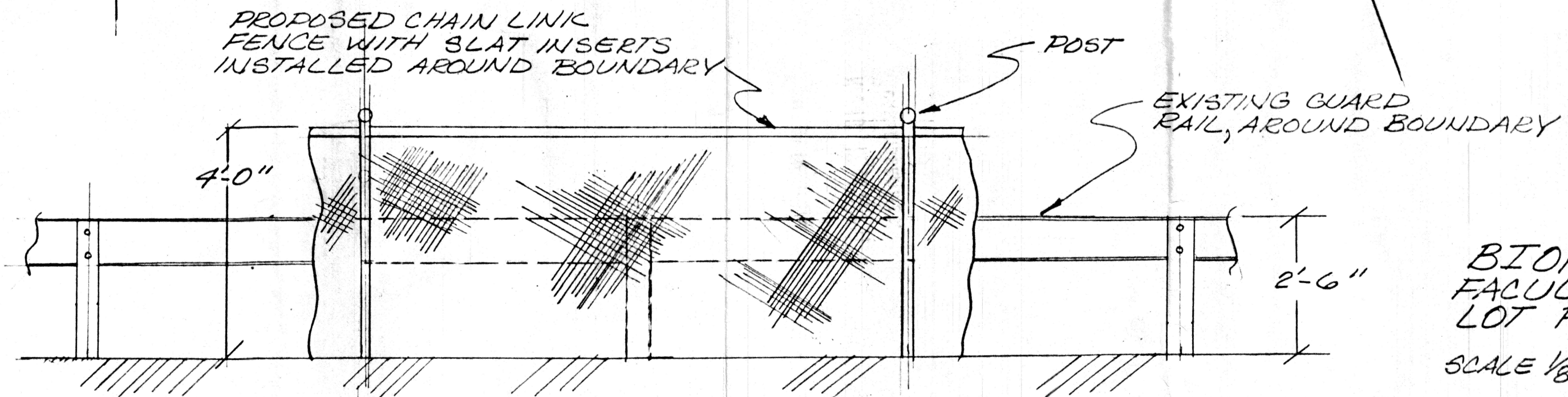
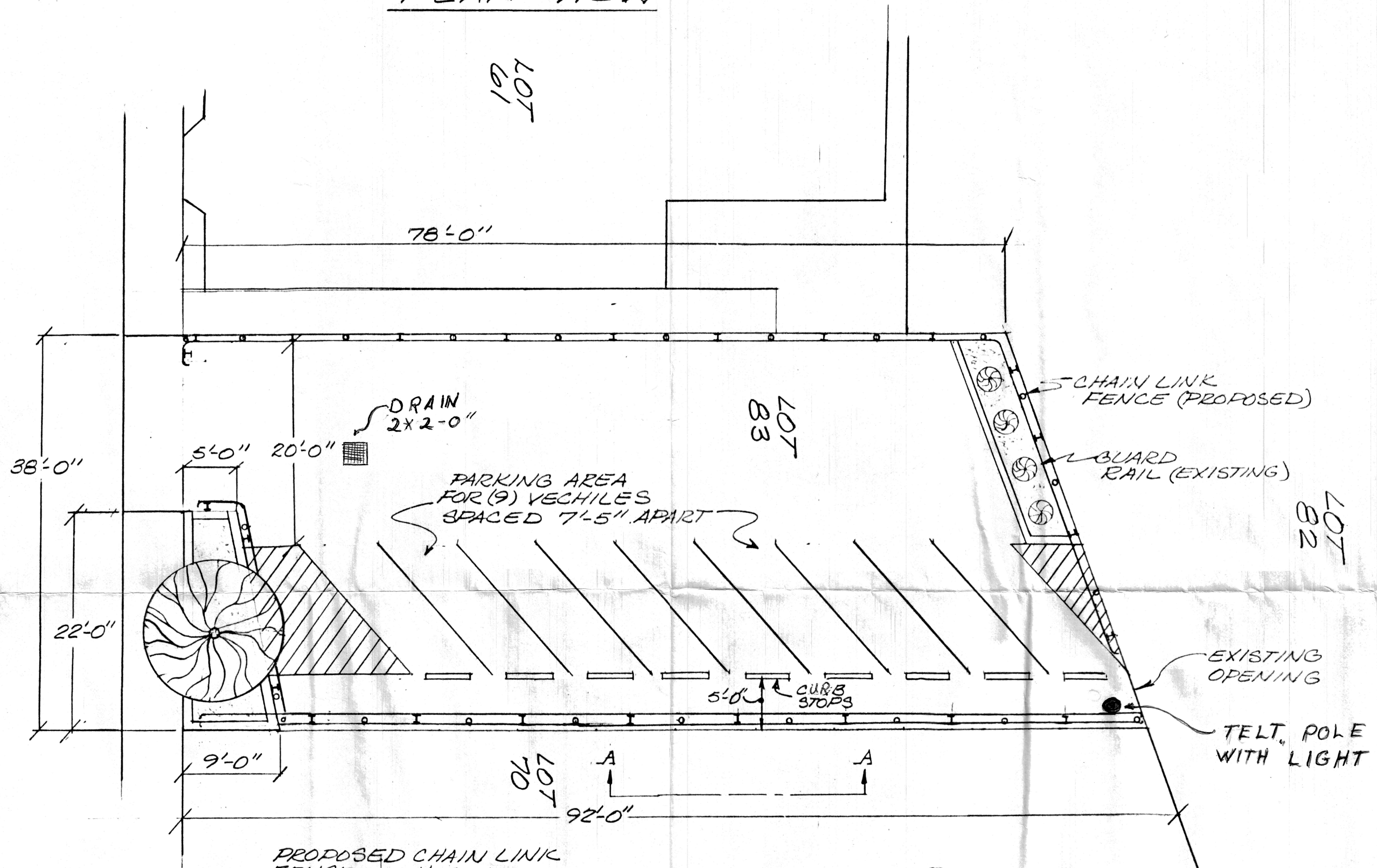
REMARKS: Concerning The CURB CUT ON COLUMBIA ST:

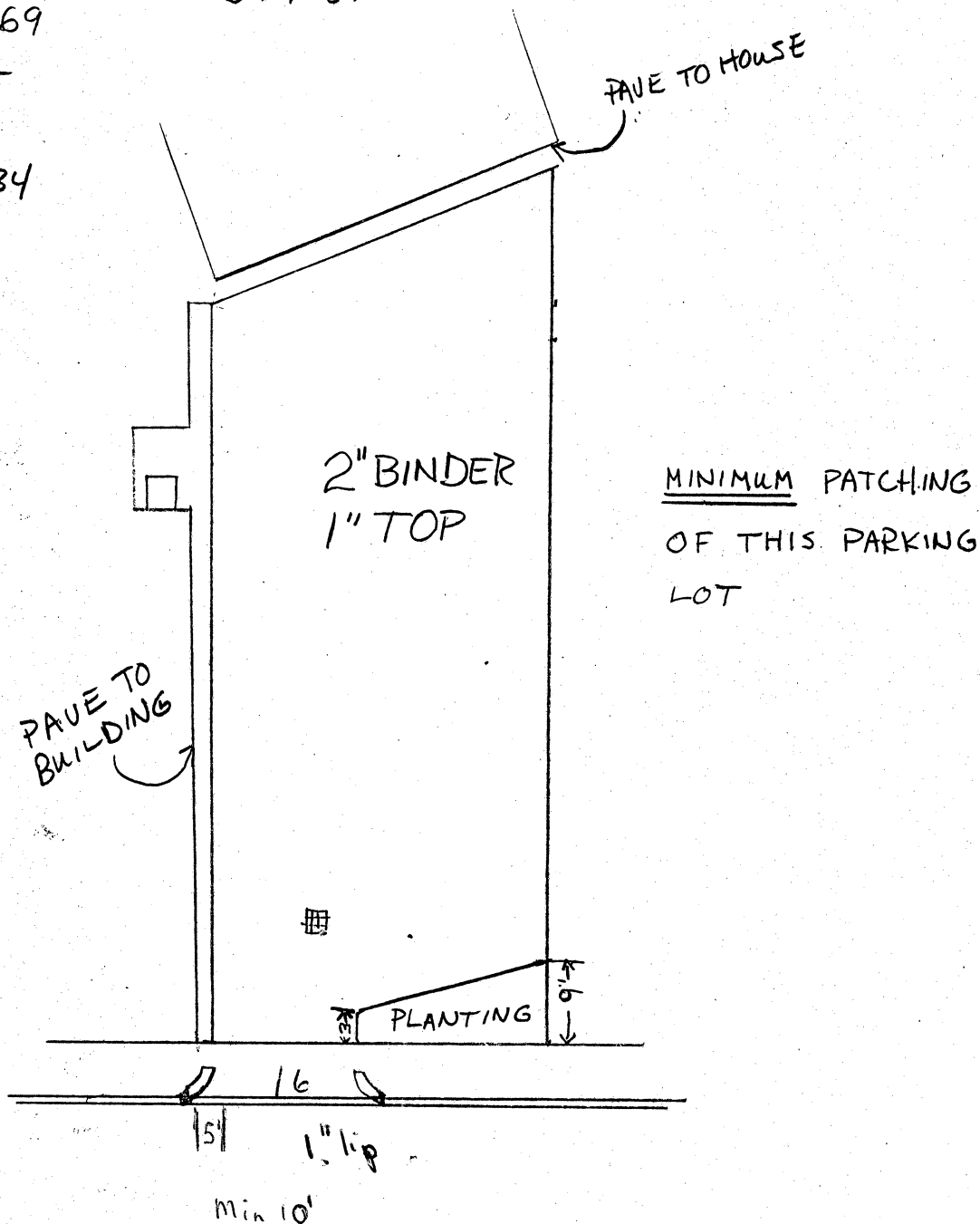
