Attached is an order requesting the appropriation of \$27,504.00 in the Grant Fund from the Federal Fuel Assistance Program Interest Earnings to the Human Services Department Salary & Wages Account \$22,504.00 and Travel & Training Account \$5,000.00. Though the administrative costs of operating the Fuel Assistance Program have increased, this year's funding allocation from the Executive Office of Communities & Development (EOCD) has been substantially reduced.
