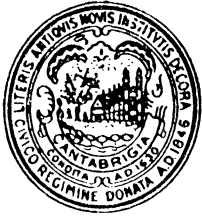

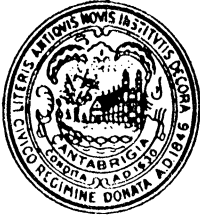

COUNCILLOR GRAHAM

- WHEREAS: That the City Council of Cambridge in session assembled on March 9, 1981 conducted a public hearing on the measures being taken to counteract the effects of nuclear warfare by the Civil Defense Department of the Commonwealth of Massachusetts; and
- WHEREAS: This City Council recieved testimony from expert witnesses, who had dedicated their lives to nuclear research, and were informed that any measures proposed by Civil Defense would be totally ineffective to protect the civilian population in the event of a nuclear attack and further that any counteraction by the United States would result in untold devastation, pestilence and the end of civilization as we know it and create an atmosphere where the survivors would be plagued by radiation in a Stone Age existence; and
- WHEREAS: The continued production of nuclear warheads by the super-powers constitutes the gravest threat to world peace due to miscalculation, human error, computer failure and the pressures of survival in a power struggle for world domination; therefore be it
- RESOLVED: That this City Council go on record urging the President of the United States, our Representatives in Congress to cease the production of nuclear weapons, to make every effort to outlaw the use of nuclear weapons, to urge the State Department and the Pentagon to freeze all nuclear weapons and concentrate their efforts on further negotiation to achieve this end by reviving the Salt II discussions despite all obstacles raised by adversaries through a massive international media education effort to all nations and to further order the Civil Defense Department to inform the citizenry of the realities of nuclear fallout, the futility of evacuation measures and the incredible devastation to civilization resulting from a nuclear arms race.
