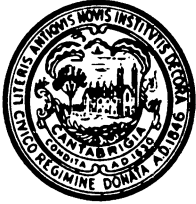

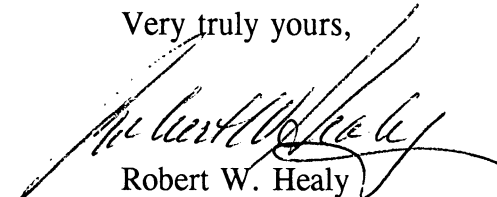

To The Honorable, The City Council:

I am hereby requesting the appropriation of \$97,910.00 into the Grant Fund of the Department of Human Services Salaries and Wages Account (\$68,095.00), Other Ordinary Maintenance Account (\$27,910.00) and Travel and Training Account (\$1,905.00) from the U.S. Department of Health and Human Services, Family and Youth Services Bureau. This grant will fund the "Area IV/North Cambridge Planning for Youth Project" under the federal Youth Gang Prevention Program. The project is funded for October 1, 1994 through September 30, 1995, and will involve adults and youth from these two neighborhoods, City representatives, community organizations and agencies and local universities in an assessment resulting in a five year plan to support the healthy development of youth. Successful projects will be eligible to apply for subsequent federal funding for implementation.
