COUNCILLOR WALTER SULLIVAN

ORDERED:

That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to The Harvard Square Business Association - (Octoberfest) for the erection of a banner behind the bandstand upon which the Octoberfest band will play; said bandstand to be located at Harvard Square from the corner of Brattle Street and John F. Kennedy Street and stretching across John F. Kennedy Street, commencing October 1st through 17th, 1982.

Provided that, before erecting the above named banner, the petitioner shall obtain a permit from the Building Department and file with the City Clerk a satisfactory bond in the sum of Two Thousand Dollars (\$2,000.00) conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said banner.

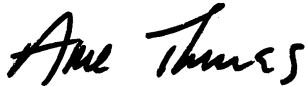
