Peabody Student Struck by a Car

Please be notified that a 4th grade, male student at the Peabody School was hit by a car this morning at the corner of Rindge Avenue and Jackson Street.

Having missed his bus, he returned home and notified his father, who is a bus driver, that he missed his bus. The father returned and motioned to his son to come to his (father's) bus. The boy was hit as he crossed the street.

The boy was taken by ambulance to the Cambridge Hospital. The Assistant Principal at the Peabody went to the hospital and reported that the boy had no visible injuries. The boy indicated that his left arm was sore, and he had some pain in the neck area.

The Police were called to the scene of the accident. They took reports from three (3) witnesses and are investigating the accident.

The student is still being evaluated at the hospital. The boy's father will notify the Peabody administrators of this son's condition.

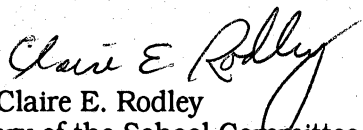
