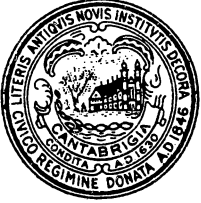

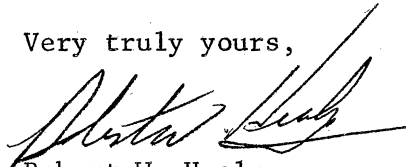
\$6,600.00	Salaries and Wages account
