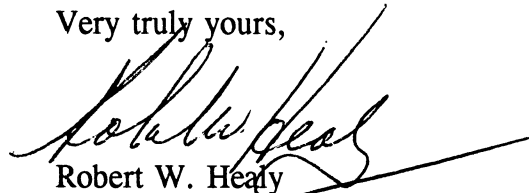

To The Honorable, The City Council:

I am hereby requesting the appropriation of \$972,199.00 in the Grant Fund of the Department of Human Services Salary and Wages Account (\$146,770.00) and the Other Ordinary Maintenance Account (\$825,429.00) from the Federal Housing and Urban Development Department. These funds will be used as Supportive Housing funds for a three year period. Funds are received directly by the Department as the lead agency for the Cambridge Supportive Housing Program. The purpose of the grant is to provide supportive housing related services to person at risk of homelessness. Funds are used for grant management support, to fund local agencies in supportive housing services, and for adult education services provided by the Department's Community Learning Center.
