for the erection of a sign at 2230 Massachusetts Avenue, Cambridge.

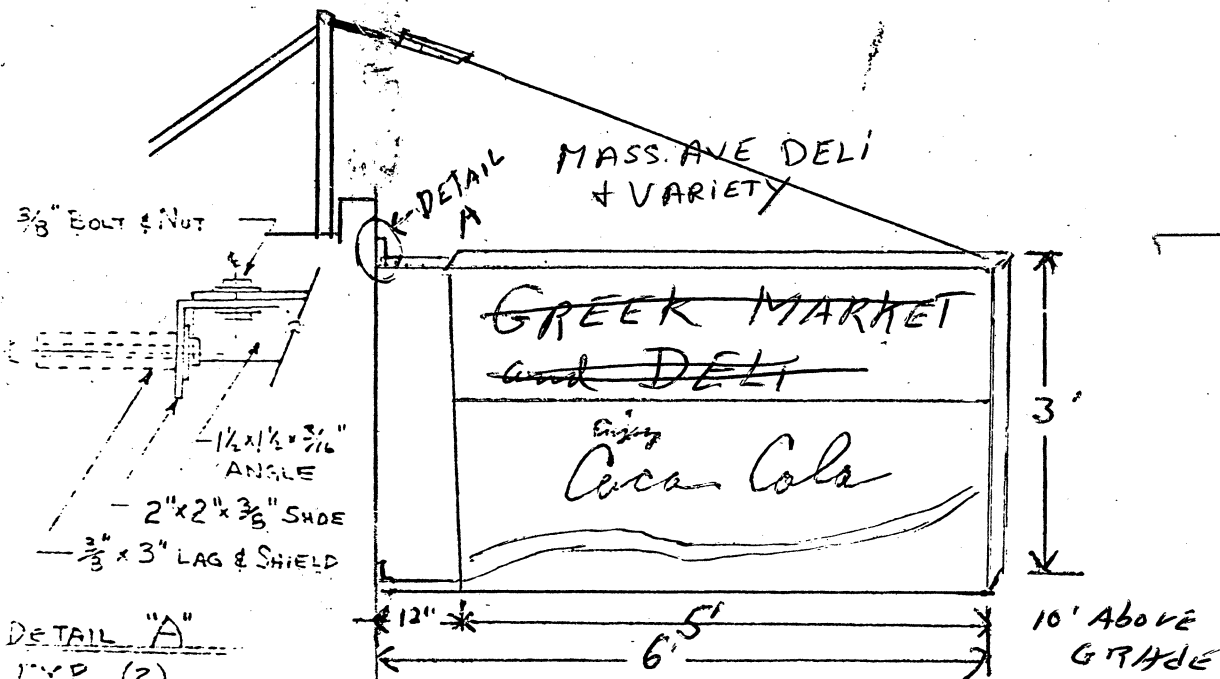

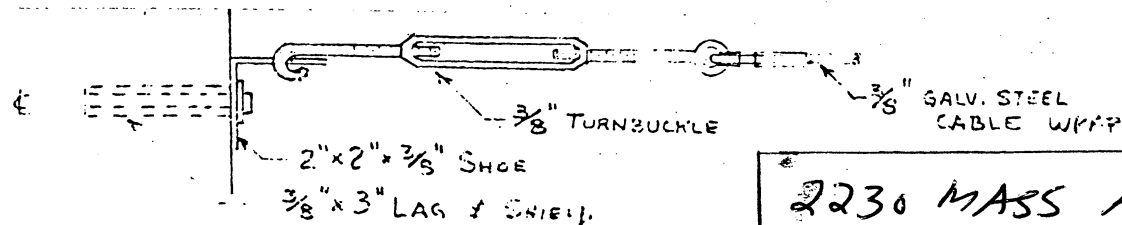

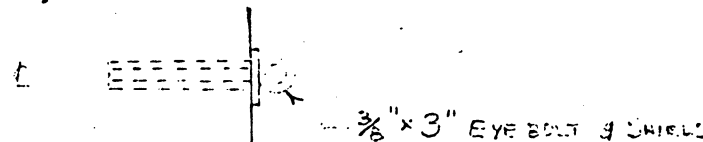
DETAIL "A"

REPLACES 4-CABLES ANTI-SWAY GUY CABLES



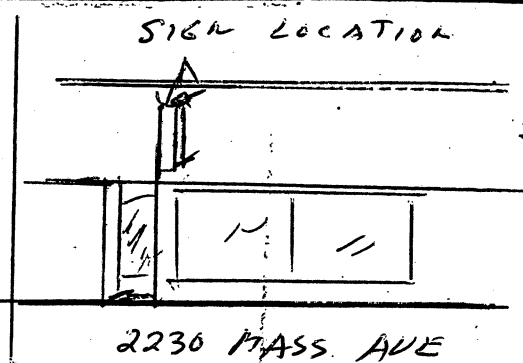
