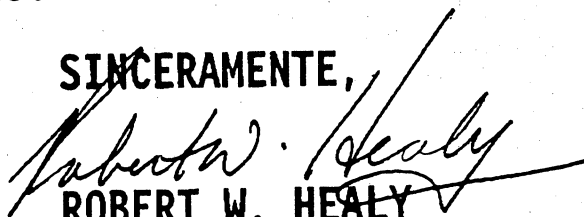

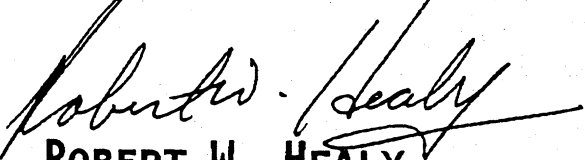

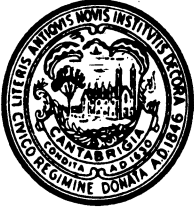

To the Honorable, the City Council:

Over the past few months, there has been much discussion about the need for a youth center in the East Cambridge and Wellington-Harrington neighborhoods. Based on the extensive needs identified, I have made a commitment to the neighborhoods to undertake a process to identify a location, to evaluate its feasibility and to recommend funding to the City Council to build a youth center serving this section of the City.

City staff from the Community Development and Human Services Departments and from my office have been extensively involved in discussions with community residents and the Youth Center Site Selection Committee about the need for a youth center and an appropriate location. A site has been identified on Donnelly Field, in an area that now contains tennis courts which are in very poor condition and are generally unused. The process to hire an architect to conduct a feasibility study has also begun. Further discussion with the City Council on funding mechanisms will be forthcoming.

A community meeting is scheduled for January 12, 1994 at 7:00 p.m. at St. Anthony's Church (400 Cardinal Medeiros Ave) to discuss issues related to this proposal. I welcome your attendance.
