ORDERED:

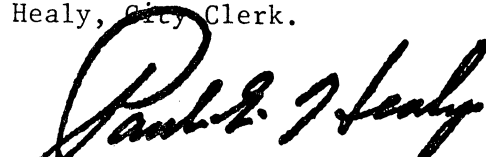

To the Honorable, the City Council of the
City of Cambridge:
