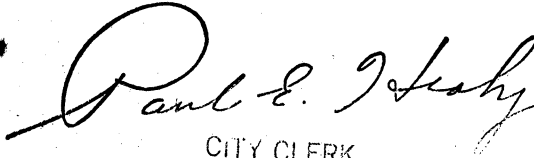

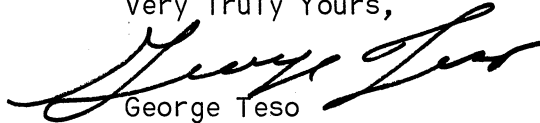

The undersigned respectfully pray that a driveway for
